WHEREAS, the City of Dothan has solicited bids for the installation of an Aquatic Play Structure at Water World; and

WHEREAS, bids were opened for said project on November 3, 2020; and

WHEREAS, Perennial South, LLC, of Dothan, Alabama, was the sole bidder with a negotiated bid of \$88,500.00.

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of the City of Dothan, Alabama, as follows:

Section 1. That the City of Dothan award the bid and enter into a contract with Perennial South, LLC, for the installation of an Aquatic Play Structure at Water World in the negotiated amount of \$88,500.00, which said bid tabulation and contract follows:

CONTRACT FORM

THIS AGREEMENT, made this 5th day of January, 2021, by

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned, to be made and performed by the OWNER, the CONTRACTOR hereby agrees with the OWNER to commence and complete the construction described as follows:

Water World Aquatic Play Structure Installation *in Dothan, Alabama*

hereinafter called the "Project", for the sum of eighty-eight thousand five hundred dollars and no cents Dollars (**\$88,500.00**), and all extra work in connection therewith, under the terms as stated in the General and Special Conditions of the Contract; and at his (its or their) own proper cost and expense to furnish all the materials, supplies, machinery, equipment, tools, superintendence, labor, insurance, and other accessories and services necessary to complete the said project in accordance with the conditions and prices stated in the Proposal, the General Conditions, Supplemental General Conditions, and Special Conditions of the Contract, the plans, which include all maps, plats, blueprints, and other drawings and printed or written explanatory matter thereof, the specifications and contract documents therefore as prepared by City of Dothan Leisure Services Department herein entitled the Architect/Engineer.

The Contractor hereby agrees to commence work under this contract on or before a date to be specified in a written "Notice to Proceed" of the Owner and to fully complete the project on or before 4/23/2021. The Contractor further agrees to pay, as liquidated damages, the sum of \$100.00 for each consecutive calendar day thereafter as hereinafter provided in the General Conditions.

The Owner agrees to pay the CONTRACTOR in current funds for the performance of the contract, subject to additions and deductions, as provided in the General Conditions of the Contract, and to make payments on account thereof as provided in "Payments to Contractor," of the General Conditions.
