**WHEREAS**, Sedgwick Claims Management, Inc., per Resolution No. 2021-291, continued to provide claims administration services for the self-insured workers' compensation program through December 31, 2021, at the previously agreed upon contracted costs; and,

**WHEREAS**, Sedgwick Claims Management, Inc., has agreed to continue to provide claims administration services for the self-insured workers' compensation program for an additional two (2) months, from January 01, 2022 through February 28, 2022, at the previously agreed upon contracted costs.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners for the City of Dothan, Alabama, as follows:

**Section 1.** That the City of Dothan enters into a modification of the previous agreement with Sedgwick Claims Management Services, Inc., to continue to provide claims administration services for the self-insured workers' compensation program at the previously agreed upon contracted costs for an additional two (2) months, from January 1, 2022 through February 28, 2022, which said agreement follows:

**ADDENDUM TO EXTEND AGREEMENT TERM FOR AN ADDITIONAL PERIOD**

This Addendum to Extend Agreement Term for an Additional Period dated December \_\_\_\_, 2021 (the "Addendum"), shall be attached to and made a part of the Service Agreement for Administration of a Claims Program dated October 20, 2020 (the "Agreement"), by and between the City of Dothan (the "Client"), and Sedgwick Claims Management Services, Inc. ("Sedgwick") (Client and Sedgwick together the "Parties").

In consideration of the Agreement recitals and the mutual covenants and conditions contained herein, the Parties acknowledge that the Agreement is hereby modified and amended as follows:

1. Section 5A of the Agreement is hereby modified and amended to provide that the Agreement term shall be extended for an additional period commencing January 1, 2022 and ending February 28, 2022.
2. Exhibit B to the Agreement is hereby modified and amended to provide that Client shall pay Sedgwick the following fees on a life of contract basis for services provided during this additional period:

**Annual Flat Fee:**

**Workers' Compensation**  
Monthly Fee \$3,862.50

All terms and conditions of the Agreement shall otherwise remain the same, except those terms and conditions which have been added, deleted, or modified by the Parties in writing.
