

RESOLUTION NO. _____

BE IT RESOLVED by the Board of Commissioners of the City of Dothan, Alabama, as follows:

Section 1. That the City of Dothan enters into an agreement with Encore Rehabilitation, Inc. for an athletic trainer to provide training services at a rate of \$40.00 per hour for a United States Tennis Association Tournament being held at Azalea Swim & Tennis Club from July 10-13, 2022, which said agreement follows:

AGREEMENT FOR ATHLETIC TRAINING SERVICES

This Agreement is made and entered into this June 24th 2022, between Encore Rehabilitation, Inc. an Alabama corporation, hereinafter referred to as "Contractor", and City of Dothan, hereinafter referred to as "City".

WHEREAS Contractor provides athletic training services in Alabama and Mississippi,

WHEREAS City has a sporting event in need of professional athletic training services ("ATC") July 10th, through July 13th, 2022.

THEREFORE, in consideration of mutual agreements and promises hereinafter set forth, the parties hereto agree as follows:

Contractor agrees to:

1. Provide Athletic Training services for City on the above dates, in Dothan, Alabama for the United States Tennis Association tournament.
2. Provide one (1) Athletic Trainer at a time, from approximately 7:00 A.M. to 7:00 P.M. providing services within their scope of practice to the athletes at a rate of \$40.00 per hour per ATC. Actual hours will be billed.
3. Contractor will provide proof of license of trainers as requested. Contractor will provide professional liability insurance for all ATC's employed by Contractor.

City agrees to:

1. Provide space for ATC to see athletes as needed.
2. Make available to Contractor all current information relating to athletes as available.
3. Pay invoice within ten (10) days of receipt. Paid to:

4. City will provide a 1099 for tax reporting purposes if payment exceeds \$600.
5. City will provide general liability coverage for the premises.
