The Board of Directors for the Wiregrass High School Umpires Association (WGHSUA), duly sanctioned by the Alabama High School Athletic Association (AHSAA), offer the following proposal to the City of Dothan:

WGHSUA promises to provide two certified officials to officiate each game for the ~~2022~~ **2023** DOTHAN DIAMOND CLASSIC Tournament. The City of Dothan agrees to pay \$60.00 per game (\$30.00 per official) for this service. The total per game amount is \$60.00.

The representative for the City of Dothan will provide the dates and starting times for all games to the Booking Agent of WGHSUA. Changes to the schedule must be received no later than 12 hours prior to the announced starting time. It is understood that weather conditions could force changes to the schedule. We request that any weather related changes be made no less than ninety minutes before the scheduled game time. If a scheduled game is canceled under ninety minutes before the scheduled game time, the assigned officials will each be paid one game fee.

The penalty for either party defaulting on any part of this contract shall be \$150.00 per failure occurrence. Failure to deliver on any part of this contract will also render the remaining part of this contract non-binding on the offended party.

WGHSUA looks forward to providing quality officiating for this softball tournament in our community. We promise to provide well trained, quality officials who are committed to the education of our young student/athletes. Thank you for giving us this opportunity.
