

RESOLUTION NO. _____

WHEREAS, the Alabama Peace Officers' Standards and Training Commission (APOSTC) agreed to open a regional police academy in the City of Dothan (City); and

WHEREAS, a Memorandum of Understanding between the City and the Alabama Peace Officers' Standards and Training Commission's Law Enforcement Academy is proposed to establish a fee structure associated with the regional police academy.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the City of Dothan, Alabama, as follows:

Section 1. That the attached Memorandum of Understanding (MOU) will be made and entered into this date by and between the City of Dothan and the Alabama Peace Officers' Standards and Training Commission's Law Enforcement Academy concerning the fees associated with the regional police academy, which said MOU follows:

1. **Parties.** This joint use agreement is made by and between The City of Dothan, Alabama as owner, and the Alabama Peace Officers' Standards and Training Commission's Law Enforcement Academy Baldwin-Wiregrass Campus.
2. **Terms of Agreement.** This agreement shall be in effect for one (1) year from the date it is signed by both parties and then from year to year, until the termination of law enforcement training by the Alabama Peace Officers' Standards and Training Commission's Law Enforcement Academy Baldwin-Wiregrass Campus, or until terminated by either party or by agreement of both parties.
3. **Location of Jointly Used Premises.** This agreement covers that at the APOSTC Law Enforcement Academy Baldwin-Wiregrass Campus will be housed on the campus of the Wiregrass Public Safety Center (WPSC) located in the city limits of Dothan, Alabama. This agreement would also permit the Alabama Peace Officers' Standards and Training Commission APOSTC Law Enforcement Academy Baldwin-Wiregrass Campus to utilize any and all facilities at the WPSC, subject to availability, and in accordance with WPSC rules and regulations.
4. **Nature of Joint Use.** APOSTC Law Enforcement Academy Baldwin-Wiregrass Campus shall be allowed to use said premises for instructional purposes, offices, and equipment storage space.

**APOSTC Law Enforcement Academy Baldwin-Wiregrass Campus
shall provide the following:**

- a. **Payment for Joint Use.** There is a one-time \$500 facility fee for the use and operations of the facilities at the WPSC that will be applied to each agency (per student) for each academy session.
- b. **Waiver of tuition for attendance of basic training for certification as a law enforcement officer as required by section 36-21-46 of the Code of Alabama at Alabama Peace Officers' Standards and Training Commission's Law Enforcement Academy Baldwin-Wiregrass Campus by any law enforcement officer or trainee employed by the Dothan Police Department when their attendance is applied for by the Dothan Police Department and their supervisor through the usual chain of command.**
- c. **All executive level administrative functions for the law enforcement academy.**
