

RESOLUTION NO. 2023-_____

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all recipients of Community Development Block Grant (CDBG) funds to prepare a list of projects for funding to receive the annual CDBG allocation; and,

WHEREAS, the City of Dothan, Alabama finds that CDBG funds are vital for providing housing assistance, neighborhood improvements, and economic development activities directed to meet the needs of low- and moderate-income persons; and,

WHEREAS, CDBG funds are an essential component in addressing housing needs, prevention and elimination of slums and blight, job creation, and addressing other community development needs having an urgency to the community's health, welfare, and safety; and,

WHEREAS, the City of Dothan has involved the public, nonprofit organizations, and other area governments to identify the 2023 CDBG projects for funding and made available for public comment according to HUD guidelines and Federal law; and,

WHEREAS, the Community Development Advisory Committee has recommended a project list and budget for inclusion into the 2023 Year Four Annual Action Plan, which will become part of the 2020-2024 Consolidated Plan based on the needs of the community as addressed in a public meeting and an assessment of the priorities of those needs; and,

WHEREAS, the City of Dothan expects to receive \$503,009.00 in CDBG Entitlement funds for Program Year 2023; and,

WHEREAS, additional funding of \$146,704.00 will be included for funds originally allocated for Moss Street Improvement Project; and,

WHEREAS, funding is reserved for Moody Senior Village Project (\$125,000.00), Wiregrass Park Sidewalk Project (\$146,704.00) and Administration (\$30,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the City of Dothan, Alabama as follows:

Section 1. That the City of Dothan, by action of the City Commission, hereby approves the 2023 CDBG projects as follows:
