# BOARD OF COMMISSIONERS CITY OF DOTHAN, ALABAMA ADJOURNED REGULAR MEETING AUGUST 10, 2021

Pursuant to adjournment of the meeting held on August 3, 2021, the Board of Commissioners of the City of Dothan, Alabama, met in adjourned regular session in the Commission Chambers of the Roy Driggers Municipal Building at 10:00 a.m. on Tuesday, August 10, 2021 with the following members present: Mayor Mark Saliba, Associate Commissioners Janasky Fleming, John Ferguson, Beth Kenward, and David Crutchfield. Associate Commissioners Kevin Dorsey and Albert Kirkland were absent.
