Dear Vendor,

In order to do business with the City of Dothan, you as a vendor must be in compliance with the Beason-Hammon Alabama Taxpayer and Citizen Protection Act, Act No. 2011-535. Your obligations can be summarized as follows:

1. PROVIDE the City of Dothan proof that you are in compliance with the immigration law by timely submitting a copy of your *E-Verify Memorandum of Understanding (MOU)*.
2. PROVIDE the City of Dothan a signed Alabama Immigration Law Compliance Contract in the attached Notice form provided.
3. PROVIDE your suppliers notice of their compliance obligations and OBTAIN from each a copy of their *E-Verify Memorandum of Understanding*.

**OR**

If you believe these obligations do not apply to you, please complete the Declaration form included. These documents will be subject to audit.

## **ALABAMA IMMIGRATION LAW COMPLIANCE CONTRACT**

Vendors of the City of Dothan must comply with Section 31-13-9, Code of Alabama 1975. If the vendor employs persons in the State of Alabama, the vendor must provide documentation that they are enrolled in the E-Verify program. This applies to any vendor entering into a written contract with the City of Dothan irrespective of whether it is a result of a competitive bid process. A copy of the Memorandum of Understanding (MOU) entered into between the contractor/business and the Department of Homeland Security to use the E-Verify system will suffice as sufficient documentation of enrollment. Any subcontractors who work with general contractors who have been awarded contracts by the City of Dothan must be enrolled in E-Verify. The general contractor should be aware of this requirement and have a system for assuring compliance. However, the City of Dothan is not responsible for assuring a subcontractor's compliance.

The award of the contract is conditioned on the vendor not knowingly employing, hiring for employment or continuing to employ an unauthorized alien within the State of Alabama.

“By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of the provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.”

A copy of our company's Memorandum of Understanding is included for companies with employees located within the State of Alabama (Your personnel department should have this or you can obtain it from the Department of Homeland security on line).
