

ORDINANCE NO. 2020-193

**WHEREAS**, the City of Dothan desires to institute the following changes to the current Code of Ordinances to formalize fees, rates and service charges that have evolved since the last approved Code changes.

**BE IT ORDAINED** by the Board of Commissioners of the City of Dothan, Alabama, as follows:

**Section 1. That Chapter 82, Solid Waste, Article I, Definitions, of the City of Dothan Code of Ordinances is hereby amended by adding the following:**

Sec. 82-1. - Definitions.

*Construction and Demolition Debris.* C&D materials consist of the debris generated during the construction, renovation and demolition of buildings, roads, and bridges.

**Section 2. That Chapter 82, Solid Waste, Article VI, Sanitary Refuse Disposal Sites and Fees, Section 82-95 of the City of Dothan Code of Ordinances is hereby amended to read as follows:**

Sec. 82-95. Schedule of fees, rates, credits, etc., for disposal.

- a) The following fees shall be paid to the city for refuse, including garbage, trash, debris, etc. delivered to the city landfill for disposal:
  - (1) Nonbusiness pickups/cars with refuse generated within the corporate limits of the city\*  
- no charge
  - (2) Houston County Sanitation Department - \$37.50 per ton
  - (3) Inside Houston County nonbusiness pickups/cars\* - \$37.50 per ton
  - (4) Commercial Waste Haulers/Other Private Entities - \$42.50 per ton
  - (5) Construction and Demolition Debris (C & D) - \$42.50 per ton
  - (6) Outside the county, excluding that area located in other counties which are a part of the corporate limits of the city, commercial, business, and residential - \$120.00 per ton
  - ✕ (7) Special Waste (Defined by ADEM Admin Code r. 335-13-1)
    - All Customers - Price per ton TBD on a case by case basis by Public Works Director or his designee. Public Works Director and his designee reserve the right to refuse any waste that may be deemed detrimental to City staff or equipment
- b) The fees in subsection (a) of this section are subject to change, by ordinance of the board of commissioners.
- c) The public works director shall have the right to waive any landfill fees in connection with public works projects within the city limits.
- d) Fees for the delivery of refuse by any person or business without an established account shall be paid at the time of delivery. For all other deliveries, statements shall be billed to the person or business making said delivery at the close of each calendar month. Such statements shall be paid within two weeks of the billing date. Failure to pay account will terminate landfill access.

\*City of Dothan and Houston County Residency must be verifiable by means of Driver's License or other means such as utility billing verifying address

**Section 3. That Chapter 82, Solid Waste, Article VI, Sanitary Refuse Disposal Sites and Fees, Section 82-98, Annual Landfill Disposal Rate Adjustments, of the City of Dothan Code of Ordinances, is hereby added to read as follows:**

Sec. 82-98. Annual landfill disposal rate adjustments.

Beginning with the October 2021 billing cycle, the landfill disposal rate fees in Section 82-95 (a) above will increase by 3 percent and then by 3 percent biannually in the October billing cycle thereafter.

Section 4. After publication as required by law, this Ordinance shall become effective immediately.
